CALL TO ORDER AND INTRODUCTIONS

Joel Pigg (AgriLife Extension), Co-Chair of the TGPC POE Subcommittee, called the meeting to order at 1:35 p.m. Attendees were introduced. The minutes were provided to the members by email for review prior to the meeting.

Recent and Upcoming Outreach Events

- Texas A&M AgriLife Extension Service (AgriLife Extension) Water Well Screening Events
 - John Smith (AgriLife Extension) reported that eight events were held in Gillespie, Culberson, Brazos, Gaines, Andrews, Lubbock, Carson, Deaf Smith, and Taylor counties where 238 samples were analyzed. He also reported that they would be in Falls County in May 2023.
- TGPC Exhibit Booth:
- There was one event booth during the last quarter. The Texas Plant Protection Association (TPPA) conference was held in Bryan, Texas on December 6-7, 2022, with about 30 attendees stopping by the booth.

TWON Training Activities

Joel Pigg (AgriLife Extension) reviewed the TWON training schedule. During the previous quarter, TWON staff held four one-day event and eight one-hour events. Staff collected 629 samples, 240 of which were from Milam and Burleson counties. There have been over 1.835 samples or attendees at TWON events since May 2021.

TGPC Website Activity Statistics

Peggy Hunka (TCEQ) reviewed the Google Analytics activity report on the TGPC web page, which showed that in the previous quarter there was a 14% decrease in the number of users and a 6% decrease in the average number of pages viewed per session. Organic searches showed that 4,066 users arrived using a web search, with Google being used most often.
