Recent and Upcoming Outreach Events

- Texas A&M AgriLife Extension Service (AgriLife Extension) Water Well Screening Events
 - John Smith (AgriLife Extension) reported there were seven events in April and May with seven more events planned for July and August.
- TGPC Exhibit Booth:
 - TCEQ's 2023 Environmental Trade Fair and Conference was held May 16-17, 2023 at the Austin Convention Center. There were approximately 515 attendees that came by and viewed the TGPC booth. We will have a booth at the TCEQ Public Drinking Water conference and the TAGD Groundwater Summit in August.

TWON Training Activities

Joel Pigg (AgriLife Extension) reviewed the TWON training schedule. During the previous quarter, TWON staff held two one-day events and one one-hour event. Staff collected 193 samples. There have been over 2,028 samples or attendees at TWON events since May 2021.

TGPC Website Activity Statistics

Peggy Hunka (TCEQ) reviewed the Google Analytics activity report on the TGPC web page, which showed that in the previous quarter there was a 1% increase in the number of users and a 6% decrease in the average number of pages viewed per session. Organic searches showed that 2,624 users arrived using a web search, with Google being used most often.
