## **MEETING RECORD OF JULY 11, 2007**

## 1. CALL TO ORDER AND INTRODUCTIONS

Bruce Lesikar (TCE), Chair of the Texas Groundwater Protection Committee (TGPC) Public Outreach and Education (POE) Subcommittee, called the meeting to order at approximately 1:12 PM CST. POE Subcommittee members were introduced. There were no concerns with the record of the previous meeting.

# 2. GROUNDWATER EDUCATIONAL OUTREACH PLAN – DRAFT IMPLEMENTATION STRATEGY

View TWDB/LCRA Major Rivers (and Groundwater) Water Education Curriculum Video

Linda Ruiz McCall (TWDB) gave an presentation on the *Major Rivers* curriculum for 4th and 5th grade students, and the POE Subcommittee watched the nine-minute introductory video that is part of the teaching package. The *Major Rivers* program provides information on the entire hydrologic cycle, including groundwater. Linda Ruiz McCall also provided information on TWDB's *Raising Your Water IQ* (for middle school students) and *Water IQ – Know Your Water* (for high school students and adults) educational outreach programs. Bruce Lesikar (TCE) then demonstrated how a table-top aquifer model could be used in outreach activities and the POE Subcommittee discussed whether this might be appropriate for the TGPC booth. Steve Musick (TCEQ) suggested that if a video could be created of the model in action, the video could be shown at the TGPC booth.

Discuss and Approve Draft Implementation Strategy

Kathy McCormack (TCEQ) pointed out the changes to the Implementation Strategy from the last POE Subcommittee meeting:

- Pages 6 7 (Issue C, Abandoned Water Well Closure), the addition of Specific Activities 2 – 5; and,
- Page 10 (Issue D, Groundwater Conservation Districts, *Major Rivers Program*), the addition of Specific Activity 3, a link to the TWDB's online evaluation form in Specific Activity 4, and several other minor wording changes.

Steve Musick (TCEQ) suggested that *Raising Your Water IQ* and *Water IQ – Know Your Water* be added to Issue D.

The Implementation Strategy will be edited further and presented to the POE Subcommittee again at the next meeting.

North-Central Texas Update PGMA Study for the Trinity Aquifer

Central Texas Update PGMA Study for the Trinity Aquifer

Fiscal Year 2007 Drinking Water and On-Site Sewage Facility (OSSF) Fact Sheets

Fiscal Year 2007 TCE Water Well Screening Events

Bruce Lesikar (TCE) reported that Monty Dozier (TCE) and John Smith (TCE) had collected a number of water well samples after the recent flooding in Marble Falls, Texas.

Fiscal Year 2007 TCE Abandoned Water Well Closures

Bruce Lesikar (TCE) reported that an abandoned, hand-dug water well closure demonstration had taken place on June 12, 2007 in Bell County in association with the Clearwater Underground Water Conservation District – it had very good media coverage due to the 20-year anniversary of the "Baby Jessica" incident (18-month-old Jessica McClure fell into a Midland, Texas well on October 14, 1987, and rescuers worked for 58 hours to free her from an 8-inch-wide pipe). Another abandoned water well closure demonstration may be coordinated in Bell County in October 2007.

Fiscal Year 2008 Planned TCE Water Well Screening Events, TCE Abandoned Water Well Closures, Reprints, and Publications

Mary Ambrose (TCEQ) suggested that a video be developed for water well capping.

TGPC Display and Booth – Recent and Upcoming Events

Kathy McCormack (TCEQ) reported on recent TGPC displays and booths:
