MEETING RECORD OF FEBRUARY 12, 2007

1. CALL TO ORDER AND INTRODUCTIONS

Bruce Lesikar (TCE), Chair of the Texas Groundwater Protection Committee (TGPC) Public Outreach and Education (POE) Subcommittee, called the meeting to order at approximately 10:13 AM CST. POE Subcommittee members were introduced. There were no concerns with the record of the previous meeting.

2. GROUNDWATER EDUCATIONAL OUTREACH PLAN

Discuss Groundwater Educational Outreach Plan Draft Implementation Strategy

Kathy McCormack (TCEQ) reviewed a proposed implementation strategy. Bruce Lesikar (TCE) suggested that there may be some beneficial interaction between Issue I (Education for Domestic Water Well Owners: Quantity) and Issue B (New Rural Landowners and Groundwater Wells).

The Subcommittee decided to ask each champion to prepare a list of short-term (less than one year to complete) and long-term (1 - 5 years to complete) activities for their Issue to be reviewed at the next meeting. Kathy McCormack (TCEQ) will prepare the outline format for everyone to use.

Identify Potential Team Members to Work on Specific Issues

During the course of the discussion, several potential team members were suggested:

- Issue G On-Site Wastewater Treatment/Disposal Systems Education Bruce Lesikar
- Issue J Groundwater and Oil & Gas Wells (*Plugging Abandoned Oil & Gas Wells*) and Groundwater and Oil & Gas Wells (*Converting Abandoned Oil & Gas Wells into Water Wells*) TDLR, TAGD, RCT

3. REVIEW AND DISCUSS AN INTRODUCTORY EDUCATIONAL BROCHURE ON PESTICIDES AND GROUNDWATER FOR THE GENERAL PUBLIC

Michael Hare (TDA) suggested that "Degradation" be added and defined under the heading "Pesticide properties that affect risk of contamination".

Monty Dozier (TCE) indicated that TCE brochures regarding pesticides in the urban environment and agricultural best management practices are available.

Bruce Lesikar (TCE) also requested feedback on the draft "Capping of Water Wells for Future Use" and "On Site Wastewater Treatment System Operation and Maintenance" fact sheets. Bruce Lesikar left the meeting at approximately 11:30 AM CST.

4. STATUS REPORTS

Fiscal Year 2007 Drinking Water and OSSF Fact Sheets

Steve Musick (TCEQ) reported that EPA funding had been secured in this fiscal year to support continuation of the water well screening outreach program, as well as to develop additional drinking water (e.g., hydrocarbon, Methyl Tertiary Butyl Ether (MTBE), Benzene Toluene Ethylbenzene Xylene (BTEX), etc.) and On-Site Sewage Facility (OSSF) Fact Sheets. Steve Musick indicated that review and input on a water well capping Fact Sheet will be solicited from TDLR, the Texas Alliance of Groundwater Districts (TAGD), and USGS.

TGPC Display and Booth – Recent and Upcoming Events

Kathy McCormack (TCEQ) reported on recent TGPC displays and booths:

Kathy McCormack (TCEQ) reported that a TGPC booth has been reserved at the TCEQ 2007 Environmental Trade Fair and Conference, May 1 - 3, 2007.

Denise Gentsch (Syngenta) suggested that the TGPC prepare a "National Groundwater Awareness Week" display for the Texas Capitol building.

5. DISCUSS EFFECTIVENESS OF TGPC OUTREACH ACTIVITIES

Abandoned Water Well Closures

Steve Musick (TCEQ) requested that Monty Dozier (TCE) provide some information on the effectiveness of their water well outreach. Monty Dozier responded that a few slides on abandoned water wells are presented at the water well screening events, and postpresentation surveys indicated increased awareness of this issue, but no follow-up has yet been performed with those water well owners that had positive contaminant screening results.

Drinking Water and OSSF Fact Sheets

Steve Musick (TCEQ) suggested that the amount of Fact Sheets that need to be reprinted may be an indication of the effectiveness of this outreach.

TGPC Display and Booth

Kathy McCormack (TCEQ) explained that the number of visitors to the TGPC booth is generally estimated as 10% of the registered conference attendees.

TGPC Website

Steve Musick (TCEQ) reported that there are no plans to perform additional TGPC website activity statistics at this time.

Steve Musick (TCEQ) encouraged all Subcommittee members to continue thinking of ways to gauge the effectiveness of our educational outreach.
